It is recommended that interested parties have a preliminary consultation meeting with City Staff. Interested parties pursuing a vacation should submit a completed Street Vacation Packet to the Department of Community and Economic Development in person, by mail or email.

STREET VACATION REQUIRED MATERIALS CHECKLIST

A completed petition packet will contain the following materials;

- Street Vacation Petition:** Completed petition will have a street/alley/place/Cul-de-sac identified, a description of the area, the number of property owners abutting the vacation area, and be signed by two-thirds (2/3) of the property owners abutting the vacation area (RCW 35.79). The last page of this petition may be copied to include additional petitioners.
- Vicinity Map:** A vicinity map identifying the general location of the vacation area relative to surrounding areas and land uses.
- Vacation Area Plan:** A plan/map clearly defining the area that is to being petitioned for vacation, including measurements or survey, North arrow, scale, date, as well as identification of all properties and their owners abutting the vacation area.

The vacation process conforms with guidelines in Title 35.79 in the Revised Code of Washington (RCW) Port Angeles Municipal Code Section 17.95.020 and 3.70.070 (P) specify zoning regulations and fees respectively.
